BYLAW NO. 552

A bylaw to amend the “Central Coast Fire Service Establishment Bylaw No. 175” (formerly “Bella Coola Fire Suppression Service Establishment Bylaw No. 175”)

WHEREAS the Regional Board of the Central Coast Regional District established by “Bella Coola Fire Suppression Service Establishment Bylaw No. 175” a Service for fire suppression;

AND WHEREAS the Regional Board of the Central Coast Regional District wishes to amend the boundaries of the Service;

AND WHEREAS the Regional Board of the Central Coast Regional District wishes to confirm that Electoral Areas ‘C’, ‘D’ and ‘E’ are the participants in the Service;

AND WHEREAS Regional Board of the Central Coast Regional District has received the consent of at least 2/3 of the participants in accordance with the *Local Government Act*;

NOW THEREFORE, the Board of Directors for the Central Coast Regional District, in open meeting assembled, enacts as follows:

1. Citation

This bylaw may be cited for all purposes as “Central Coast Fire Service Amendment Bylaw No. 552, 2025”.

2. Amendments

“Bella Coola Fire Suppression Service Establishment Bylaw No. 175” is hereby amended as follows:

a) By deleting section 4 in its entirety and replacing it with the following:

“Citation

1. This bylaw may be cited as the “Central Coast Fire Service Establishment Bylaw No. 175, 1992”.

b) By deleting section 1 in its entirety and replacing it with the following:

“Service Established

2. There is hereby established a Service, to be known as “The Central Coast Fire Service” for the purposed of providing fire suppression.”

c) By adding section 3 as follows:

“Service Area Boundaries

3. The boundaries of the Service shall be comprised of those portions of Electoral Areas 'C', 'D' and 'E' shown outlined on Schedule 'A' attached to and forming part of this bylaw."
- d) By amending the boundaries of the Service to include the properties outlined in black on Schedule 'B' attached to and forming part of this bylaw.
- e) By adding section 4 as follows:

"Participants

4. The participants in the Service are Electoral Areas 'C', 'D' and 'E'."
- f) By deleting Section 2 in its entirety and replacing it with the following:

"Cost Recovery

5. The annual cost of providing the Service shall be recovered by one or more of the following methods in accordance with Section 378 of the *Local Government Act*:
 - a. Property value taxes;
 - b. Parcel taxes;
 - c. Fees and charges;
 - d. Revenues raised by other means authorized under the *Local Government Act* or another Act;
 - e. Revenues received by way of agreement, enterprise, gift, grant or otherwise."
- g) By renumbering Section 3 accordingly.
- h) By deleting Schedule 'A' in its entirety and replacing it with Schedule 'A' attached to and forming part of this bylaw.

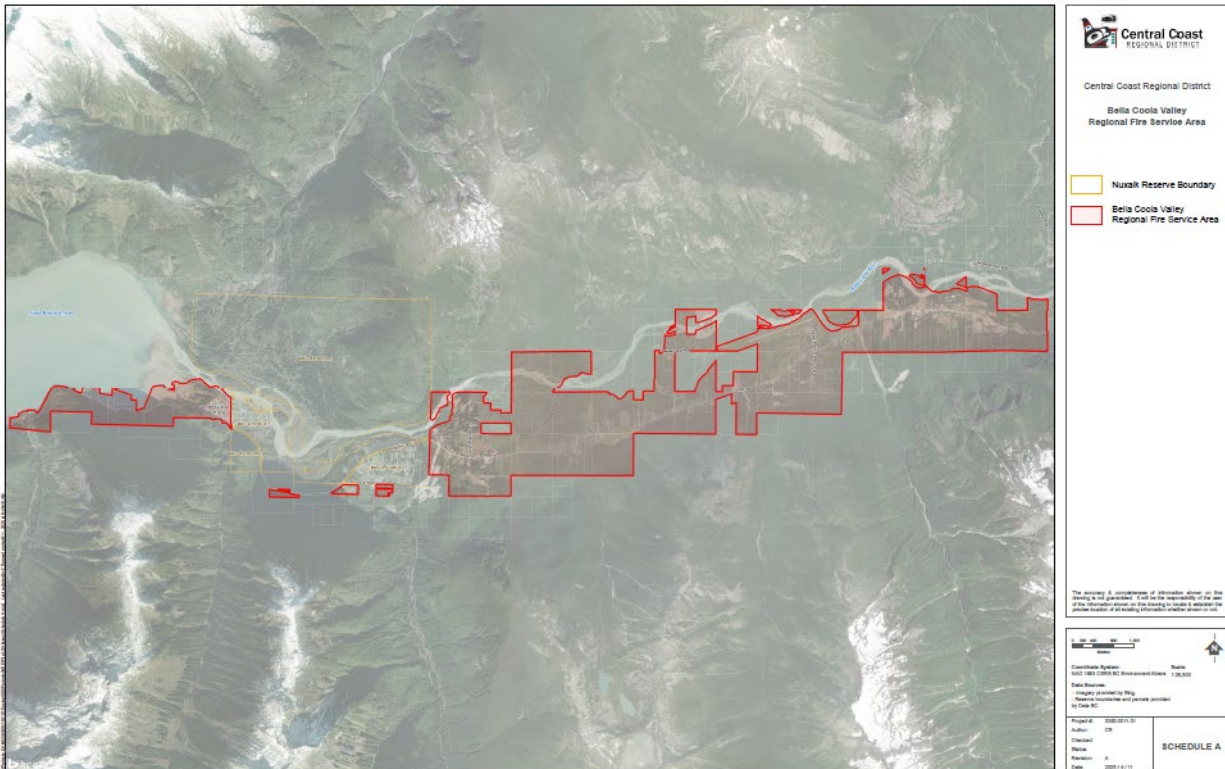
