**BYLAW NO. 524**

**Centennial Pool Rates & Charges Bylaw**

---

A bylaw to establish the rates and charges for the operation and management of the Centennial Pool and to repeal Bylaw No. 496.

---

WHEREAS the Board of Directors for the Central Coast Regional District has adopted the “Central Coast Regional District Swimming Pool Conversion and Service Establishment Bylaw No. 409, 2011” with Electoral Areas C, D & E participating;

AND WHEREAS pursuant to Section 397 of the *Local Government Act* (RSBC 2015) the Board may impose fees and charges in respect of the operation and management of the Centennial Pool;

AND WHEREAS the Board of Directors for the Central Coast Regional District deem it necessary to establish the rates and charges for the Centennial Pool;

AND WHEREAS it is deemed necessary to amend these rates and charges from time to time;

NOW THEREFORE the Board of Directors for the Central Coast Regional District, in open meeting assembled enacts as follows:

1. Bylaw 496 cited as the “Centennial Pool Rates & Charges Bylaw No. 496, 2020” is hereby repealed;
2. The rates and charges as set out hereunder are hereby authorized and fixed for the Hagensborg Centennial Swimming Pool:

Family (up to 2 adults and 4 youth/student)	\$12.00	Includes GST
Youth 10 swim pass*	\$28.00	GST not applicable
Student 10 swim pass*	\$28.00	Includes GST
Adult 10 swim pass*	\$40.00	Includes GST

**PROGRAMS:**

LSS Swim for Life lessons	\$50.00/set	Includes GST
Private lessons**	\$20.00/half hour	Includes GST
Semi-private lessons (2-3 students)**	\$12.50/half hour	Includes GST
Staff assistance for young children**	\$25.00/hour	Includes GST
Private Rental (11-30 bathers)**	\$95.00/hour	Includes GST
Private Rental (over 30 bathers)**	\$120.00/hour	Includes GST

Others, such as higher-level aquatics courses rates, are set by CCRD administration factoring industry standard, cost recovery and enrollment.

\*10 swim passes must be used within the pool season in which they are issued. No refunds will be issued for unused passes.

\*\*All private lessons, 1:1 staff assistance for children, and pool rentals are subject to pool staffing capacity. Programming may be cancelled by the regional district without notice, in which event any deposits or fees charged by the regional district will be refunded.


3. The regional district reserves the right to require a deposit on all program bookings and registrations. Parties that book pool rentals and fail to show, will be charged the full rate of the rental. Any refund of registration or rental deposits will be reviewed and approved/denied on a case-by-case basis by the Pool Manager, taking into account extenuating circumstances and the ability of the regional district to fill the vacated rental or registration slot.
4. This Bylaw may be cited as “Centennial Pool Rates and Charges Bylaw No. 524, 2023”.


