#### 1. Call to Order

The CAO called the meeting to order at 7:05 p.m., welcoming everyone to the inaugural meeting of the new CCRD Economic Development Advisory Committee.

- **(b)** Introduction by all Committee members and reasons why they wished to be on the Economic Development Advisory Committee (EDAC).

After each committee member spoke, CAO Darla Blake reminded the committee that the EDAC was more than a Bella Coola Valley EDAC and that the intention by the CCRD Board is to have an EDAC that is representative of the CCRD region.

#### 2. Nominations and Appointment of Chair and Vice Chair

The CAO called for nominations to the position of Chair and Vice Chair of the EDAC:

The work plan included in the agenda was based on the needs of the CCRD, the outcomes of the Strategic Planning process and Economic Development Collaborative meetings held during 2014. The CEDO will provide assistance and support to the EDAC.
