



What is the Regional Board?

What electoral areas are in the Region?

The Central Coast Regional District is made up of 5 electoral areas.

- Area A Outer Coast (includes Ocean Falls, Denny Island, Oweekeno)
- Area B Bella Bella (includes all of Campbell Island)
- Area C Upper end of Bella Coola Valley, including Stuie, Firvale, and part of Hagensborg
- Area D includes some of Hagensborg, stretching from Augsburg Church west to Tatsquan Creek





 Area E includes Bella Coola townsite, and areas to the north and south of the North Bentinck Arm.

Who is on the CCRD Board of Directors?

The CCRD Board of Directors is made up of


- 5 electoral area directors
 elected by voters in each electoral area
 - Where no one is elected, the Board must appoint a representative.





Director gets one vote.

What services do I receive from the CCRD?



Services often considered "local government" services are provided to the region by multiple agencies, including:

First Nations

The Nuxalk, Heiltsuk and Wuikinuxv First Nations provide many services to their members, including water, fire protection, recreation, economic development, land use planning, solid waste, as well as broader services such as health and wellness, social services, housing, fisheries, forestry and marine use.

- Roads (local road & highway maintenance, snow clearing)
- Subdivision approval
- Policing (through RCMP)
- Health (through Vancouver Coastal Health)

Improvement Districts

- Hagensborg Improvement District
 - Water
 - Fire protection
- Noosatsum Improvement District
 - Water
 - Fire protection
- Ocean Falls Improvement District
 - Water
 - Sanitary & storm sewer
 - Fire protection
 - Emergency response
 - Parks and recreation

What do my regional district services cost?

How do I calculate what I pay?

- The following tax bill includes only CCRD services. Those • services delivered by other governments (improvement districts, province) are not included on this tax bill.
- The CCRD services you receive and pay for depend on where in • the Region you live.
- Property owners in the Bella Coola townsite receive water, street • lighting and fire protection from the CCRD. The cost of those services is at the bottom of the tax bill.



How are CCRD services paid for?


- Senior government grants
 - Provincial grants to Regional Districts
 - Community Works Fund (gas tax)
 - Federal grants
- Other grants available for projects from different organizations
- Property tax
 - Based on assessed values
 - Parcel taxes (water)
- User fees
 - Recreation fees, airport fees


CCRD Revenues Sources 2015



- Contributions from Nuxalk First
 Nations
 - Service agreement regarding solid waste
- Other revenues
 - Interest income, investment income, lease agreements, donations, counter sales
- Surplus/reserves
 - Revenues earned and set aside from previous years

In addition to electing and speaking with your Electoral Area Director, residents can participate in decision-making by being appointed to a Commission or Committee.

Commissions & Committees

Economic Development Advisory Committee

- Advisory only (no decision-making authority)
- 10 members (1-year terms)
 - 1 representative from each of Nuxalk First Nation, Heiltsuk First Nation,
 Ocean Falls, Denny Island, Bella Coola Harbour Authority, CCRD Board
 - 4 members at large

Denny Island Recreation Commission

- Administer and operate recreation service
- 5 members (2-year terms)



- 1 regional representative, 4 members at large

Denny Island Airport Commission

- Operates Denny Island Airport, including small budget for maintenance and repairs, and provides advice to Board
- 6 members
 - 1 CCRD member, and 5 members at large (1-year terms)

Centennial Pool Commission

- Operates and programs Centennial pool and provides advice to Board
- 7 members (1-year terms)


What other opportunities are there to be involved?
