We saw high engagement from residents that are advocating for local choice when it comes to treatment options for the Hagensborg Water System. The CCRD recognizes that one-size-fits-all treatment approach doesn't work for everywhere in BC, and we are pushing this issue with Provincial representatives.

Board discussions about investing in the Thorsen Creek Landfill continue, with improvements aimed at ensuring long-term sustainability and complying with the Environmental Management Act.

All told, we've had a fast paced and very vibrant spring. Thank you for continuing to shape the work that the Central Coast does through your input, questions and support. While there are critical investments being made in the future of the community, we're still celebrating the things that make the Central Coast great!




2025 Budget Process Wraps Up

The Central Coast Regional District (CCRD) gave final reading and adoption of its Five Year Financial Plan on March 27, 2025. This was the result of months of community engagement that started in August 2024, including surveys, mail-outs, public meetings, and open houses to ensure community priorities shape the budget.



Denny Island Discourse!

CCRD staff visited Denny Island in March to discuss emergency preparedness, economic development and some technical options being considered for implementing water services on the island.

More than 20 Islanders joined CCRD staff at the Denny Island Community Centre to discuss these topics and more.

Did You Know? Marine Plan Partnership (MaPP)

The Marine Plan Partnership (MaPP) is a marine planning initiative between the Province and coastal First Nations. The Central Coast Marine Plan was completed in 2015. While the plan is not legally binding, it is an important document used by provincial decision-makers to guide marine use and management across the region.

The plan uses ecosystem-based management and draws from both Indigenous knowledge and science. It provides strategic direction for how the region's marine areas may be used or protected in the future. More information is available at: mappocean.org/central-coast.

Board Reviews 2025 Advocacy Priorities

At their March meeting of the Board, the 2025 advocacy issues report was on the table.

Some of the regional needs discussed by the Board were:

- improvements to inconsistent summer ferry services;
- advocating for dedicated seniors' housing in the Bella Coola valley;
- fairness for property assessments by requesting in-person property assessments be performed;
- local choice in water treatment options; and,
- CCRD inclusion in the Northern Living Allowance zone.

At the end of debate, the CCRD Board directed that meetings be set to discuss these issues and more with Provincial representatives.

Heads Up: Hagensborg Water Service

Stemming from the 2025 Budget process, the Hagensborg Water Service will see gradual water rate increases beginning this year.

There are two main reasons for this: to save funds for system improvements as grant programs to improve distribution become available, and to gradually save for the future: so that system repairs and replacements are able to be made without big tax jumps in the future.

For 2025, residents can expect to see an annual increase of \$77 (to \$352) for a single family dwelling.

BC Valley Tourism Leads 2025 Community Clean-up

Bella Coola Valley Tourism led a community clean-up in the Bella Coola Valley on Saturday, April 12.

After a brief presentation from the BCVT about the event in March, the Board offered support to the group through waiving up to \$500 in landfill fees for the clean-up.

Congratulations to event organizers for putting on another great annual clean-up to make the Valley "cleaner and greener!"

Fire Services Merge Moves Ahead

The Central Coast Regional
District (CCRD) is in the process
of merging the Hagensborg and
Bella Coola fire services to
create a unified fire service with
two fire halls.

Since the Board decision to move to next steps on the merge in February, CCRD staff are preparing the legal steps to merge the services, and are working with Fire Department Volunteers toward a smooth transition to a unified fire service.
