A message from Vancouver Coastal Health

- Assessment and testing is available by contacting the Band office or by coming to the hospital. You will
  be directed to the appropriate location at each site for further assessment and to determine if
  swabbing is necessary. Saline gargle tests are also available for school age children. Testing between
  the hours of 10am -2pm. Our emergency department remains open 24/7 for urgent and emergent
  care needs.
- Medical clinic continues to offer phone appointments to assess if a face to face visit is necessary.
   Hours remain unchanged 8:30am to 4:30pm
- Essential visitation is in place at hospital/long term care which will be reassessed on October 6th. Please respect management/physician/nursing direction as to whether a visit can occur.
