The Association of Vancouver Island and Coastal Communities (AVICC) will be held in Victoria on Friday, April 1 to Sunday, April 3 in Victoria. The Electoral Area Directors' Forum will be Tuesday, April 5 to Wednesday, April 6 in Richmond. It would be beneficial to change the Thursday, April 14, 2022 regular Board meeting to Friday, April 8, 2022. The Friday, April 8 meeting could be held in person to help save costs.

If the Board were to have an Outer Coast meeting it is recommended in June in hopes to align with a possible Ocean Falls Revitalization Committee Meeting.
