CCRD COMMUNITY ECONOMIC DEVELOPMENT HIGHLIGHTS

Economic Development Advisory Committee

The next EDAC meeting is scheduled for May 25th 2017. There is an open call for Expressions of Interest (EOI) for members at large to the CCRD Economic Development Advisory Committee (EDAC). All interested community members are encouraged to contact the Community Economic Development Officer.

Two submissions have been received in response to the call for EOI. The attached letters outline an interest in participating in EDAC and provide background information:

- Rodney Krimmer is the president of Bella Coola Community Forest Board of Directors and is a local, independent wood and timber builder.
- Robert Duncan is the Tribal Manager for the Wuikinuxv Nation and has worked in economic development over the past 20-years, primarily working with First Nations communities.

As outlined in the EDAC Terms of Reference, appointments to the EDAC shall be by resolution of the CCRD Board.



Grant Writer

The funding application to Northern Development Initiative Trust (NDIT) for support to hire a Contract Grant Writer was successful. A job posting for the contract position has been posted on the CCRD website and Facebook page and an advertisement has been placed in the Coast Mountain News.

The objective of the Grant Writer is to secure more funding dollars to support community economic development projects and initiatives within the CCRD. Under supervision of the CEDO, the Grant Writer will work with community organizations to increase their success in accessing financial grants in pursuit of strategic priorities.

As noted in the Community Economic Development Report to the Board, dated November 3, 2016, organizations who have expressed an interest in accessing the Grant Writer include: Bella Coola Harbour Authority, Bella Coola Valley Tourism, Bella Coola Trails Alliance, Central Coast Chamber of Commerce/Denny Island Community Development Association, and Bella Coola Valley Sustainable Agriculture Society. A document with information about preparing to work with a contract Grant Writer has been put together for community organizations.

The CEDO will work with the Economic Development Advisory Committee to establish a process for allocating the Grant Writer's time.

Love Central Coast

An application for a Ministry of Transportation sign permit is being prepared for the Love Central Coast sign. One location currently under consideration is near the existing pull-out and tourist information signage, located on the North side of Highway 20, less than one kilometer West of the bottom the Hill.

Vancouver Coastal Health (VCH) Active Communities Grant

The CEDO worked with the Denny Island Recreation Commission to submit a Letter of Community Interest for the Active Communities Grant. If approved, selected local governments will be notified in June 2017 to begin work on project development in partnership with VCH staff.

This is an excellent opportunity to begin implementing the recently signed collaborative agreement with Vancouver Coastal Health.

Audio and Visual Recording of Board Meetings

The Broadcasting Report dated January 28th 2016 was reviewed. Options for live streaming of Board meetings and for alternative conference phone options are being explored and a report will be prepared for the June 2018 regular meeting of the Board.



CCRD STRATEGIC INITIATIVES

Official Community Plan Update 2017 Strategic Priorities and Goals:

The CEDO and TLC have been in communication with the planning consultant to discuss next steps for the Official Community Plan Update. Staff have started a review and revision of the draft Terms of Reference and development of an engagement strategy for the OCP update process to ensure a high level of community input. The engagement process undertaken for the CCRD Solid Waste Management Plan has been reviewed and will help to inform the OCP engagement strategy.

BACKGROUND

The third intake of the BC Rural Dividend Fund (BCRDF) has a deadline of May 31, 2017.

The four project categories are as follows:

Workforce Development

Community and Economic Development

Business Sector Development

The CCRD is considering submitting an application to BCRDF for a Strategic Economic Lands Availability Assessment. The CCRD has also been contacted for a Letter of Partnership Support for an application being submitted by Nuxalk Nation and for a Letter of Project Support for an application being submitted by Community Futures Cariboo Chilcotin.

CCRD STRATEGIC ECONOMIC LANDS AVAILABILITY ASSESSMENT PROPOSAL

The Central Coast Regional District is interested in pursuing the opportunity to apply to the BC Rural Dividend Fund for a Strategic Economic Land Availability Assessment. This project would involve mapping to gain an understanding of the characteristics of the land supply in the CCRD and the opportunities available to support a diversified local economy and sustainable economic development in the region.

The proposed assessment can help to define what lands may be suitable for development. It would not mean that the CCRD supports those sites for development or that planning permission would automatically be given for these sites.

LETTER OF PARTNERSHIP REQUEST- NUXALK NATION PROPOSAL

The attached request is for a Letter of Partnership Support for Nuxalk Nation's application to the BC Rural Dividend Fund. The proposal is for a *Nuxalk Pathway to Aboriginal Tourism Project* that encompasses the Nuxalk Big House & Multiplex, Cultural Pathway and Four Mile Trail.

The funding guidelines state that a partner must play an active role in the project and must provide a partnership letter, to be submitted with the online application form. There is no requirement for the partner (CCRD) to contribute financially to the project, to sign the grant agreement, or to be involved in the reporting of the project. In addition, there is no limit to the number of applications that can supported by the Regional District.

The role of the CCRD may include:

- Working in a collaborative and reciprocal nature with Nuxalk Nation to further the Bella Coola Valley as a world class Aboriginal tourism destination.
- Participating in regular briefing meetings and, where appropriate acting to facilitate conversations with stakeholders, in relation to the development of Nuxalk Big House & Multiplex, Cultural Pathway and Four Mile Trail.
- Collaborating on strategies, such as the Nuxalk Cultural Pathway to Aboriginal Tourism Project, that support the cultural, environmental, social, and economic wellness of the region.
- Continuing to provide advice and work together to address concerns that may arise in relation to setback variations, land use planning, trails and recreation infrastructure (as was previously done in Phase 2 of the Nuxalk Cultural Pathway to Aboriginal Tourism).
- Participating in joint meetings to begin a working relationship to further economic and tourism development in the region.

A partnership letter would confirm the CCRDs role and commitment in the Nuxalk Pathway to Aboriginal Tourism Project.

LETTER OF SUPPORT REQUEST – COMMUNITY FUTURES CARIBOO CHILCOTIN PROPOSAL

The attached request is for a Letter of Project Support for Community Futures Cariboo Chilcotin's application to the BC Rural Dividend Fund. The proposal is for a *Planning a Successful Succession Project* aimed at small/medium sized business owners who are looking to retire from their business/sell their business. The program has been developed to reduce the number of business closures so that goods and services can stay in local communities to support economic stability and job security in communities.

Community Futures has found that when it comes time to think about selling a business, owners are not familiar with the process. The proposed program will provide a step-by-step process for those individuals to follow with the outcome being a viable business exit strategy plan.

Community Futures Cariboo Chilcotin service delivery area extends to the Bella Coola Valley so participants from Electoral Areas C, D, and E will be able to participate in the proposed program. The proposed plan is to hold periodic workshops either in person or on the web. Much of the work will be one-on-one, primarily electronically due to the distances, and in person when feasible.

Community Futures Cariboo Chilcotin is hoping to submit their proposal the week of May 23rd, 2017.

CCRD OPERATIONS APRIL 2017 HIGHLIGHTS

SOLID WASTE MANAGEMENT

- Solid Waste Planners Carry McIver and Maura Walker presented on behalf of the CCRD at the Coast Waste Management Association AGM in Duncan. The Regional District Round-up is a chance for member Regional Districts to share success stories and challenges from the past year.
- Purchasing of a used roll-off truck is complete. A 2005 tandem axle Sterling with a 52,000
 lbs Stellar hook lift was purchased from Mack trucks of Victoria for \$33,500 plus applicable
 taxes and fees. The truck is being shipped to Abbotsford for bin fitting at Wasteline
 Containers Ltd.
- 3. Ads, flyers, posters, mail-outs and a social media campaign have been, or are being completed to promote the spring cleaning event at Thorsen Creek Waste and Recycle Centre. The Landfill and Recycling Depot will be open the weeks of May 8th-13th and May 23rd-27th. During this period, tipping fees will be reduced by 50% for all loads of sorted residential waste.

RECREATION FACILITIES

- CCRD issued a Request for Expressions of Interest from parties qualified to operate the concession building at Walker Island Park over summer months. No expressions of interest were received before the deadline of May 1.
- 2. Debris from winter storms has now been cleared from Walker Island Park and Snootli Creek Trails.
- CCRD has exercised an option to extend the park facility maintenance contract with Matthews Contracting in an amount of \$870.00 per month. This is the first of two possible one year extensions.
- Centennial Pool: New Waves Pools is currently trying to find a suitable compatible roll on liner product that will smooth the existing surface and help solve the algae build up. With pool opening currently scheduled for June, time lines are tight.

BELLA COOLA TOWNSITE WATER SYSTEM AND FIRE PROTECTION

- At the request of the Nuxalk FD, BCVFD responded to a fire call April 15th in 4-Mile subdivision regarding a house fire. The fire was extinguished without damage to surrounding property, however the house was a total loss.
- 2. Train the Trainer training took place the weekend of April 22. The training involved all local departments and was organized by Christina Hoppe in her role as dispatcher for the Nuxalk FD. Feedback from participants was that the training was very valuable and relevant to our operations. BCVFD members are attending further live fire training in 100 Mile House the weekend of May 6th.

STRATEGIC INITIATIVES

CENTENNIAL POOL UPGRADE

CCRD has engaged Urban Systems in their role as Engineers of Record to complete a technical memorandum supporting our pool renewal project. Architect Bruce Carscadden has been engaged to further develop concept option 2 and hire a quantity surveyor to further develop costs.

SOLID WASTE MANAGEMENT PLAN (SWMP) UPDATE

The complete plan is now ready to submit to the Ministry of Environment. A letter asking of the Ministry to expedite the review process is being crafted.

SHEARWATER WATER SYSTEM STRATEGIC PRIORITIES FUND GRANT

APPLICATION

RECOMMENDATION

That Central Coast Regional District Board of Directors approves CCRD administration to submit a grant application to the Strategic Priorities Fund for construction of the Shearwater/Denny Island Water System.

BACKGROUND

For many years, the residents, elementary school and businesses of Denny Island have lobbied for access to potable water. To this day, the school and most residents in the vicinity of Shearwater, still obtain water from Croil Lake through the original surface water intake system installed by the RCAF in the 1940s.

In 2012, Shearwater Marine successfully drilled two productive wells in close vicinity to Shearwater. Discussions began around the potential of constructing a small community water system to service the school, businesses and residents in the Shearwater area of Denny Island.

In 2014, CCRD identified Shearwater/Denny Island Water as a top 3 strategic priority of the Regional District and hired John Motherwell and Associates Engineering Ltd. to prepare a conceptual design of a new water system to service the Shearwater area. The conceptual design and a successful petition for service provided the basis of a grant application to the Strategic Priority Fund (SPF) in early 2015 for 1.8 million dollars, essentially 100% of the estimated project costs. In early 2016, nearly a year after applying to the Strategic Priority Fund, CCRD was notified that we were not successful in our funding application.

In 2016, School District #49 (SD#49) used the Conceptual Water System Engineering Design provided by CCRD to access significant capital funding from the Ministry of Education to drill and develop wells capable of supplying potable water to the Shearwater School (Phase 1). This work was undertaken successfully, with reports provided in November 2016. SD#49 received funding approval for development and installation of a treatment and distribution system (Phase 2). Currently applications are underway by SD#49 engineers to acquire statutory right of way for water mains and licence of occupation for a reservoir site.

Shearwater/Denny Island Water is part of the CCRD Strategic Plan and remains on the work plan going forward. Staff have been in regular contact with SD#49 and their engineers to stay apprised of progress.

DISCUSSION

UBCM recently announced another intake of funding applications was underway for the Strategic Priority Fund. Applications are being received until June 1, 2017. The Shearwater/Denny Island Water System project qualifies for funding under this program. Each eligible Local Government may submit two applications under the SPF-Capital Infrastructure Projects stream. To date, the CCRD Board has given approval for an application to the SPF for the Centennial Pool Renewal Project in Hagensborg. Approval by the CCRD Board of an application to SPF for the Shearwater/Denny Island Water System would constitute the second and final application allowed by CCRD for this intake.

SD#49 has been approached and has expressed interest in acting as a funding/construction partner for this project. Most of the funds they have allocated to Phase 2 of their project can act as leveraging funds to access the SPF grant money. This is a strong consideration during the evaluation process. Although the SPF allows for up to 100% funding of projects, the evaluation committee is keen to see local governments or funding partners put up capital as well.

Pending CCRD Board approval for this application, Urban Systems will be contracted to prepare a concept design merging all the design work done to date by different parties and come up with a plan to efficiently deliver potable water to the Shearwater area and eventually expand to service larger areas.

BUDGET/FINANCIAL IMPLICATIONS

Five thousand dollars is budgeted in the CCRD Feasibility Study Fund for engineering work in support of Shearwater/Denny Island Water. This money was budgeted to allow for modification of our engineering design to reflect the new well locations and proposed work by SD#49.

RISK MANAGEMENT

There is expected to be minimal operational or financial risk associated with submission of an application to SPF for funding. Professional water system engineers are being hired to develop and cost out a concept that will form the basis of the application. Utilization of qualified professionals helps to mitigate risk.

CONCLUSION

Access to potable water is critical to the future health and prosperity of Shearwater and Denny Island. Schools should have the ability to offer students potable water without having to truck in bottled water year after year.

Growth in the community is severely limited without access to potable water. Subdivisions are not approved, mortgages are difficult and it is a challenge to attract residents and businesses to the area.

In order to move the project forward, it is recommended that the Board of Directors approves CCRD administration to proceed with an application to the Strategic Priority Fund for construction of the Shearwater/Denny Island Water System.

They are requesting the regional district to submit a proposal to the Strategic Priorities Fund with Wukinuxv Nation being the ultimate recipient. The project is for the Nicknaqueet River Hydropower Project, and the value of the project has not been stated at this stage.

According to the March 2017 Program Guidelines for the Federal Gas Tax Fund Strategic Priorities Fund (Capital Infrastructure Projects Stream) each local government is allowed to submit 2 applications. In April, the board approved the application already in progress related to the Swimming Pool project, that being a strategic priority for the current year.

Also on the agenda this month, is a report from the Operations Manager requesting the board's consideration of another application to the Strategic Priorities Fund in favour of water system improvements on Denny Island, which has been a long standing and unresolved matter in the regional district's strategic planning.

In the course of business, had we already received approval from the board to proceed with the application for Denny Island Water, the proponents of the hydropower project would've been advised that our maximum number of applications (2) had already been reached; however, since approval for our second application has not yet been granted by the board, it appears there are two applications, only one of which may proceed.

I spoke with Rebecca from UBCM and she provided the following information:

- 1. If approved, the funding agreement will be between UBCM and CCRD, so in general CCRD will be responsible for submitting the claims forms and fulfilling reporting requirements;
- 2. This funding is a claim based program so expenditures occur first then the recipient submits claims to receive refund. In this case, there will only be 1 lump-sum claim. I think UBCM holds back 15% of the claim amount until reporting requirements are fulfilled, so in theory, CCRD will have minimum two monetary transactions with UBCM and Wuikinuxv each.
- 3. Minimum reporting required is the submission of annual expenditure report, which she told me that the Regional Districts will have to do anyways.
- 4. There may be additional project specific reporting requirements but they will be identified in the funding agreement
- 5. The actual fund will flow from UBCM to CCRD. CCRD would then sign an MOU with Wuikinuxv Nation to flow fund from CCRD to Wuikinuxv.

As discussed, Wukinuxv/Barkley will complete the funding application package, compile claim package, and provide additional reports as required by the agreement. Therefore, it appears that CCRD would be responsible for:

- 1. Submission of application package (Wukinuxv will provide the package)
- 2. Upon funding approval, signing of funding agreement with UBCM
- 3. Signing of MOU with Wuikinuxv
- 4. Submission of claim package(s) (Wuikinuxv will provide the package)
- 5. Receiving funds from UBCM
- 6. Transferring funds to Wuikinuxv
- 7. Submission of annual expenditure report
- 8. Submission of project specific reports (Wuikinuxv will provide the reports)

TRANSPORTATION APRIL 2017 HIGHLIGHTS

1. Work is now underway on the 2017 obstacle removal project at the Bella Coola Airport.

To date, the following works have been completed:

- · Hiring of contract project manager;
- · Completion of an environmental assessment and recommendations;
- Meetings with Nuxalk Nation Chief Councilor and Stewardship Office to discuss project and seek official support;
- Hiring of mapping contractor to supply digital mapping and GIS support for the project;
- Completion of mapping and integration of obstacle limitation survey;
- Engagement with private landowners regarding obstacles located on private property;
- Preparation and submission of applications for a Forestry Licence to Cut and an amendment to CCRD's existing Licence of Occupation at Snootli Creek Regional Park;
- Field work to identify operational challenges;
- Engagement with Pacific Coastal Airlines to determine most limiting obstacles for scheduled service:



- Meetings with Transport Canada to clarify airport standards and corrective actions required to bring aerodrome into compliance with TP312 regulations;
- Field work portion of Archeological Overview Assessment and CMT survey; and
- Legal survey and marking of private property boundaries in the vicinity of proposed operations.
- · Topping of 3 large spruce east of the airport;
- Felling of large spruce and cottonwood east of airport and large cedar west of airport;
- Brushing of east face of dike and east side of Nooklikonnik Creek
- · Old fencing removal; and
- Engagement of SNC Lavalin to provide analysis of option around TP312 4th and 5th edition obstacle clearances.

The project is on schedule with the exception of licence approval for clearing activities on crown land. The project is still expected to be primarily complete by late fall, with the exception of field prep and seeding etc. which will likely have to wait until spring of 2018.

- 2. And draft mini-Airport Operations Manual has been submitted to Transport Canada to facilitate Authorized Status. No feedback has been received as of yet. An authorization visit by Transport Canada Inspectors has not yet been confirmed.
- 3. The Brushing contract was awarded for Denny Island Airport and the work is now complete.
- 4. ACTION ITEM: Stephanie Quinn, the current leaseholder of Lot 7 at the Bella Coola Airport, has requested her lease be assigned to a numbered company of which she is the sole shareholder. Ms. Quinn is also requesting a renewal of the lease agreement when it expires May 31, 2017. The tenant is in good standing with the Regional District and a renewal is determined to be of mutual benefit to both parties.

Being a bylaw to repeal the Centennial Pool Regulation Bylaw No. 460, Centennial Pool Rates and Charges 2016 and replace with Bylaw 474 Centennial Pool Rates and Charges 2017.

WHEREAS the Board of Directors of the Central Coast Regional District is authorized, by section 225 of the Local Government Act, 2015 and section 122 of the Community Charter to exercise powers by bylaw or resolution, and accordingly.

AND WHEREAS the Board may fix and charge fees for admission or use of the Centennial Swimming Pool;

AND WHEREAS it is deemed necessary to amend these fees from time to time;

NOW THEREFORE, the board of directors for the Central Coast Regional District, in open meeting assembled, enacts as follows:

- 1. Bylaw 460 cited as the "Centennial Pool Rates and Charges No. 460, 2016." is hereby repealed.
- 2. The Centennial Swimming Pool is hereby authorized to be open during such periods as are specified hereunder:

May 1ST to September 30TH; seven days a week, 7:00 am to 9:00 pm.
