## GENERAL VOTING DAY – OCTOBER 20, 2018

General voting will be open to qualified electors of the Central Coast Regional District on **Saturday, October 20, 2018, between the hours of 8 a.m. and 8 p.m.** at the following voting locations:

### MAIL BALLOT VOTING

Mail ballot voting will be available to qualified Central Coast Regional District electors if they:

1. Have a physical disability, illness, or injury that affects their ability to vote at another voting opportunity; OR
2. Expect to be absent from the district on General Voting Day (October 20, 2018) and at the advance voting opportunity (October 10, 2018).
3. Live in Ocean Falls (contact person Gladys Suderman), Denny Island (contact person Betty Hadley) or Wuikinuxv (contact person TBD).

Applications to receive a mail ballot will be accepted until 4:00 pm on October 12, 2018. Mail ballots will become available on or before October 5, 2018. It is the responsibility of the elector to ensure the ballot is returned to the Chief Election Officer or Deputy Chief Election Officer, Central Coast Regional District, before the close of voting at 8:00 pm, Saturday, October 20, 2018.

### ELECTOR REGISTRATION AT THE VOTING PLACE – IDENTIFICATION WILL BE REQUIRED

If you are not on the list of electors, you may register at the time of voting by completing the required application form available at the voting place. To register you must meet the following qualifications:

- 18 years of age or older on General Voting Day (October 20, 2018);
- Canadian citizen;
- Resident of British Columbia for at least six months immediately preceding the day of registration;
- Resident of the Central Coast Regional District OR a registered owner of real property in the Central Coast Regional District for at least 30 days immediately preceding the day of registration; and
- Not disqualified under the *Local Government Act* or any other enactment from voting in an election or otherwise be disqualified by law.

**To register, resident electors** will be required to produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification



must prove both residency and identity.

**To register, non-resident property electors** must produce **2 pieces of identification** (at least one with a signature) to prove identity, proof that they are eligible to vote in relation to the property, and, if there is more than one owner of the property, **written consent** from the other property owners.
