REQUEST FOR PROPOSALS

REMOVAL OF METALS FROM THORSEN CREEK LANDFILL SITE

The Central Coast Regional District (CCRD) is inviting proposals from firms interested in undertaking removal of all metals currently stored at the Thorsen Creek Landfill site in Bella Coola, B.C.

Please note the following information:

1. The work is to be complete by August 31, 2015.
2. The metals pile is mixed with no separation of non-ferrous metals. 'White goods' containing refrigerant are separated.
3. There are approximately 3 end of life vehicles, one of which has paperwork documenting all fluids and tires have been removed.
4. The pile is roughly 50m long at the base, 12m wide at the base and averages about 4m in height. Very rough calculations put the volume around 1350 m³. This is only a rough estimate and interested parties are expected to verify volumes for themselves.
5. Please see the attached pictures of the metal pile taken February 11, 2015.
6. The contractor will remove all metals and 'white goods' and not high grade.
7. The metal pile is not fenced and the work site is not secure.
8. There are numerous fridges and freezers containing refrigerant that the contractor will be responsible for evacuating.
9. The CCRD will agree to assist the successful proponent in maximizing metal collection through a Valley-wide promotional campaign encouraging metal delivery to the landfill site and waiving tipping fees for disposing of metal items (subject to restrictions) at the landfill for a limited duration while the contractor is on site.
10. Before submitting a proposal, the proponent shall carefully examine the site of the works and shall fully inform him or herself as to the existing volume of metals and any other conditions and limitations which may influence the proposal or execution of works.
11. The CCRD reserves the right to accept or reject any or all proposals and to waive any informality in bids received.
12. The CCRD will select a frontrunner proponent and enter into negotiations to clarify details and enter into a signed agreement. Should the parties be unable to reach a

satisfactory agreement, the CCRD may discontinue negotiations with the initial frontrunner and select another frontrunner proponent.

13. Proponents not utilizing barging should investigate seasonal road restrictions on Highway 20 that could impact hauling.
14. Proponents are encouraged to present different options and cost proposals.
15. The CCRD accepts no financial or legal responsibility or liability for the materials after they have been removed from the landfill site.
16. The successful contractor will be required to work around public traffic on opening days which is currently every Wednesday and Saturday. This may be increased to three days per week for the summer months.
17. The successful proponent will be required to provide proof of general liability insurance in the amount of 2 million dollars and must be in good standing with WorkSafe BC.

Proposals will include the following information:

1. Company/Firm overview and any additional information if multiple parties are involved.
2. Cost – all found.
3. Timeline for completion.
4. Process for removal and recycling (including equipment involved, ability to deal evacuation of fluids from end of life vehicles, staging location, method of transport and destination for delivery).
5. Evidence that the metals are to be transported to a scrap metal dealer and not simply moved to another disposal site.
6. References for similar projects.

Proposals will be accepted at the Central Coast Regional District office until 4:00 p.m. Thursday March 12th, 2015.
