Instructions and Application for the 2026 General Local Election

How to Apply

1. Complete this application form and mail, email, fax, or deliver it to the Chief or Deputy Chief Election Officer at the address below.

2. If your application is complete and you qualify to vote by mail ballot, a mail ballot package will be sent to you as soon as the ballots are available. Please note that depending on the timing of your application, there may not be sufficient time to mail the ballot to you and for you to return it. We recommend that you arrange to pick up a mail ballot package from the Central Coast Regional District office.

3. **You are responsible for ensuring that your completed ballot and documents are received by the Chief Election Officer no later than 8:00 pm on Saturday, October 17, 2026, the close of voting.** Mail ballots received after the close of voting cannot be accepted.

a resident of British Columbia for at least six months immediately before the
general voting day (at the time of voting); and
a resident of the Regional District; or a non-resident owner of real property in the
Regional District for at least 30 days immediately before general voting day; and
not disqualified by law from voting in an election or otherwise disqualified by law.
